

“The draft of a Mutual Divorce Agreement (Divorce by Consent) in accordance with Thai law”

MUTUAL DIVORCE AGREEMENT (DIVORCE BY CONSENT)

This Agreement is made and entered into on [Date], by and between:

"Husband",

and

ARTICLE 8: MISCELLANEOUS

8.1 Any amendments or modifications to this Agreement must be made in writing and signed by both Parties.

8.2 If any part of this Agreement is deemed invalid or unenforceable, the remaining provisions will continue to be valid and enforceable.
